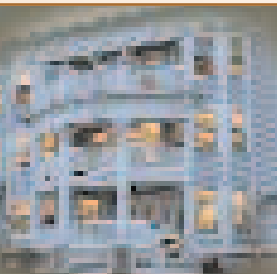
Preserve. Educate. Inspire.
